ΘΕΜΑ: Ισχύς ελληνικών και ξένων αδειών οδήγησης στην Ελλάδα

Σε εφαρμογή του άρθρου 94 του ν. 2696/1999 «Κύρωση του Κώδικα Οδικής Κυκλοφορίας» (Α΄57), λαμβανομένων υπόψη των ανωτέρω σχετικών, και επειδή το Υπουργείο μας γίνεται αποδέκτης πολλών γραπτών και προφορικών ερωτημάτων αναφορικά με το δικαίωμα οδήγησης οχημάτων στη χώρα μας με ελληνικές και ξένες άδειες οδήγησης, σας γνωρίζουμε τα ακόλουθα:

Α. Δικαίωμα οδήγησης στην Ελλάδα, ανά κατηγορία ελληνικής άδειας οδήγησης

Στον Πίνακα 1 του Παραρτήματος που επισυνάπτεται, αναφέρονται αναλυτικά τα δικαιώματα οδήγησης στην Ελλάδα με ελληνική άδεια οδήγησης και ανά κατηγορία αυτής, σύμφωνα με τις διατάξεις του π.δ.51/2012 (Α΄101). Ο Πίνακας αυτός παρατίθεται προς διευκόλυνση και στην αγγλική γλώσσα.

Β. Δικαίωμα οδήγησης στην Ελλάδα από πολίτες που δεν κατέχουν ελληνική άδεια οδήγησης

- 1. Δικαίωμα οδήγησης με ξένη εθνική άδεια έχουν οι κάτοχοι ισχύουσας άδειας οδήγησης που έχει εκδοθεί από:
- α. Κράτος-μέλος της Ε.Ε., καθώς και από τα κράτη Νορβηγία, Ισλανδία, Λιχτενστάιν, που αναφέρονται στον Πίνακα 2 του Παραρτήματος που επισυνάπτεται. Σύμφωνα με την ευρωπαϊκή νομοθεσία (άρθρο 2 και 6 της Οδηγίας 2006/126/ΕΚ, καθώς και την Απόφαση (ΕΕ) 2016/1945 της Επιτροπής για την ισοδυναμία μεταξύ κατηγοριών αδειών οδήγησης), εκδοθείσες άδειες από τα προαναφερθέντα κράτη που χορηγούνται για οποιαδήποτε κατηγορία ισχύουν και για οχήματα της κατηγορίας ΑΜ (μοτοποδήλατα και ελαφρά δίκυκλα και τετράκυκλα, όπως ορίζονται από τον Κανονισμό 168/2013/ΕΕ).
- β. Την Ελβετία και ισχύει ως έχει επί του ελληνικού εδάφους επί 12 μήνες από την είσοδο του/της κατόχου της στην Ελλάδα, σύμφωνα με τις διατάξεις του ν. 1333/1983 (Α΄31) με τον οποίο κυρώθηκε η «Συμφωνία για αμοιβαία αναγνώριση της άδειας οδήγησης αυτοκινήτων και μοτοσικλετών μεταξύ της Ελλάδας και της Ελβετίας». Μετά την πάροδο 9 μηνών από την είσοδό του/της κατόχου στην Ελλάδα, μπορεί να αιτηθεί τη μετατροπή της σε αντίστοιχης κατηγορίας ελληνικής άδειας οδήγησης, σύμφωνα με τα οριζόμενα στην υ.α. 50984/7947/2013 (Β΄3056), εφόσον επιθυμεί να οδηγεί στην Ελλάδα και μετά το δωδεκάμηνο παραμονής του/της στη χώρα μας.
- γ. Τη Σερβία, την Αλβανία και τα Ηνωμένα Αραβικά Εμιράτα και ισχύει ως έχει επί του ελληνικού εδάφους έως ότου οι κάτοχοι της αποκτήσουν τη συνήθη διαμονή στην Ελλάδα. Μετά την απόκτηση της συνήθους διαμονής στην Ελλάδα οι κάτοχοί της, εφόσον επιθυμούν να οδηγούν στην Ελλάδα, οφείλουν να τις μετατρέψουν σε ελληνικές σύμφωνα με τα οριζόμενα στην υ.α. 50984/7947/2013 (Β΄3056).
- δ. Συμβαλλόμενο κράτος στη Σύμβαση της Βιέννης (άρθρο 94§3(δ) του ΚΟΚ), εφόσον οι κάτοχοι δεν έχουν την κανονική τους διαμονή στην Ελλάδα και η άδεια είναι σύμφωνη με τις διατάξεις του Παραρτήματος 6 «Εθνική Άδεια Οδήγησης» του ν. 4266/2014 (Α΄135). Κατά την έκδοση της παρούσας τα συμβαλλόμενα κράτη αναφέρονται στον Πίνακα 4 του Παραρτήματος που επισυνάπτεται. Επισημαίνεται ότι ο επικαιροποιημένος πίνακας (σε πραγματικό χρόνο) με τα κράτη που έχουν προσχωρήσει στη Σύμβαση της Βιέννης μπορεί να αναζητείται στην επίσημη ιστοσελίδα του Οργανισμού Ηνωμένων Εθνών στο σύνδεσμο:

ε. Τρίτη χώρα, εφόσον οι κάτοχοί της είναι μέλη διπλωματικών αποστολών και προξενικών αρχών, μέλη Διεθνών Οργανισμών και Γραφείων Διεθνών Οργανισμών στην Ελλάδα, καθώς και τα μέλη

των οικογενειών των ανωτέρω που είναι ήδη κάτοχοι άδειας οδήγησης και υπό την προϋπόθεση ότι είναι υπήκοοι τρίτων χωρών, πλην των κρατών-μελών της Ευρωπαϊκής Ένωσης, της Νορβηγίας, της Ισλανδίας ή του Λιχτενστάιν και κάτοχοι Δελτίου Ταυτότητας εκδοθέντος από τη Διεύθυνση Εθιμοτυπίας του Υπουργείου Εξωτερικών. Η ισχύουσα άδεια οδήγησης πρέπει να συνοδεύεται από βεβαίωση της εκδούσας αρχής, για το δικαίωμα οδήγησης οχήματος βάσει των κατηγοριών που κατέχουν, επίσημα μεταφρασμένης (άρθρο 94§3(στ) του ΚΟΚ).

- στ. Κράτος στο οποίο δεν εκδίδεται διεθνής άδεια οδήγησης, εφόσον οι κάτοχοι της δεν έχουν τη συνήθη τους διαμονή στην Ελλάδα και μόνο για τα παρακάτω οχήματα: μοτοποδηλάτων, μοτοσικλετών, μηχανοκίνητων τρικύκλων, τετρακύκλων και επιβατικών αυτοκινήτων. Για την οδήγηση των υπόψη οχημάτων από τους/τις ανωτέρω απαιτείται η κατοχή ισχύουσας εθνικής άδειας των αντίστοιχων κατηγοριών υπό την προϋπόθεση ότι συνοδεύεται από επίσημη μετάφρασή της στην ελληνική ή αγγλική γλώσσα (άρθρο 94§3(ζ) του ΚΟΚ).
- ζ. Τις Ηνωμένες Πολιτείες Αμερικής, τον Καναδά, την Κοινοπολιτεία της Αυστραλίας, το Ηνωμένο Βασίλειο και το Γιβραλτάρ κατά τη διαμονή (στην περίπτωση αυτή ως διαμονή νοείται τόσο η προσωρινή όσο και η συνήθης διαμονή) των κατόχων τους στην Ελλάδα και για τα παρακάτω οχήματα: μοτοποδηλάτων, μοτοσικλετών, μηχανοκίνητων τρικύκλων, τετρακύκλων και επιβατικών αυτοκινήτων. Για την οδήγηση των υπόψη οχημάτων από τους/τις ανωτέρω απαιτείται η κατοχή ισχύουσας εθνικής άδειας των αντίστοιχων κατηγοριών υπό την προϋπόθεση ότι συνοδεύεται από επίσημη μετάφρασή της στην ελληνική ή αγγλική γλώσσα (άρθρο 94§3(ζ) του ΚΟΚ). Η μετάφραση απαιτείται μόνο στην περίπτωση που οι εγγραφές επί της άδειας οδήγησης δεν είναι στην ελληνική ή αγγλική γλώσσα. Για την κατανόηση των κατηγοριών που κατέχει κάποιος κάτοχος άδειας οδήγησης Ηνωμένων Πολιτειών Αμερικής, Καναδά και Κοινοπολιτείας της Αυστραλίας σχετικά πίνακες 5, 6 και 7 του Παραρτήματος αντίστοιχα.
- 2. Δικαίωμα οδήγησης στην Ελλάδα με διεθνή άδεια οδήγησης έχουν οι κάτοχοι ισχύουσας διεθνούς άδειας οδήγησης, η οποία έχει εκδοθεί από οποιοδήποτε κράτος, εκτός της Ελλάδος και οι οποίοι δεν έχουν τη συνήθη διαμονή τους στην Ελλάδα. Προκειμένου η διεθνής άδεια οδήγησης να έχει ισχύ θα πρέπει να συνοδεύεται από την ισχύουσα εθνική άδεια οδήγησης του κατόχου της.

Αυτοί οι πίνακες αφορούν άδειες οδήγησης που έχουν εκδοθεί από τις Ηνωμένες Πολιτείες Αμερικής, τον Καναδά και την Κοινοπολιτεία της Αυστραλίας. Επισυνάπτεται Πίνακας σε μορφή pdf που περιέχει όλη την πληροφορία για τις κλάσεις των αυστραλιανών αδειών οδήγησης καθώς και τα έντυπά τους.

A motor vehicle (other than a motorbike) with a GVM not over 4.5t that is constructed or equipped to seat not more than 12 adults (including the driver); tractor or implement; and, motor vehicle mentioned above that is towing a single trailer with a GVM not over 9t (but not two or more trailers).

Class R - Motorcycle licence

A motorbike towing a single trailer designed to be towed by a motorbike.

LR - Light rigid vehicle licence

A motor vehicle with a gross vehicle mass (GVM) over 4.5 tonne, but not over 8 tonne.

A motor vehicle with a GVM not over 8 tonne that is constructed or equipped to seat more than 12 adults (including the driver).

A motor vehicle that is towing a single trailer with a GVM not over 9 tonne. However, this class does not cover a motor vehicle that is towing: 2 or more trailers; or a single trailer with a GVM over 9

MR - Medium rigid vehicle licence A motor vehicle with 2 axles and a gross vehicle mass (GVM) over 8

tonne.

Under section 10 of the Road Transport (Driver Licensing) Regulation 2000, the Road Transport Authority (RTA) may impose conditions on a driver licence using the following condition codes:

- **A** The licence holder must drive a motor vehicle fitted with automatic transmission. This includes Tiptronic transmission vehicles. A Tiptronic transmission is an automatic transmission type which allows the driver to manually override the automatic shift.
- **B** If the licence holder is the driver of a motor vehicle of a kind for which a light rigid vehicle licence or driver licence of a higher class is required, the vehicle must be fitted with a synchromesh transmission or automatic transmission.
- **D** The licence holder is an accredited rideshare driver, view more information about Rideshare accreditation.
- **E** If the licence holder is the rider of a motorbike, it must be of restricted engine capacity as notified in writing by the Road Transport Authority to the holder.
- H The license holder is an accredited hire car operator, view more information about Hire car accreditation.
- I The licence holder must drive only a motor vehicle fitted with a breath alcohol interlock device.
- **M** The licence holder is an accredited hire motorcycle operator, view more information about Hire car accreditation.
- O The licence holder is an accredited bus driver, view information about Bus service accreditation in the ACT.
- **Q** Presently, the ACT *Road Transport (Driver Licensing) Regulation 2000* does not provide for a 'Q' condition code. However, legislation in some jurisdictions, such as New South Wales do provide for a 'Q' condition code. In those jurisdictions, a 'Q' condition code is issued to temporary overseas visitors who apply for an Australian driver licence. The purpose of the 'Q' condition is to indicate that the licence holder has not provided proof of permanent Australian residency.
- **S** The licence holder must wear corrective lenses at all times while driving.
- T The licence holder is an accredited taxi operator, view information about Taxi service accreditation in the ACT.
- **V** The licence holder must drive only a motor vehicle fitted with driver aids, or modified, as notified in writing by the Road Transport Authority to the holder.
- **W** The licence holder is an accredited restricted hire car operator, view more information about Hire car accreditation.
- X The licence holder must comply with any condition of which the holder has been notified in writing by the Road Transport Authority.

Provisional licences are issued for a period of 3 years and now consist of two licence stages. The licence stages are:

P1

Where a red P plate must be displayed for the first 12 months and late-night peer passenger restrictions apply.

P2

Where a green P plate for the remaining 2 years must be displayed. If you are 25 or older when you are issued with your provisional licence, you will be a P2 for the entire 3-year provisional licence period.

If you have an existing ACT Provisional licence, it is recommended that you display GREEN plates for the remainder of your tenure. It is an offence to drive a motor vehicle that displays incorrect 'L' or 'P' plates, including the wrong colour.

Provisional licence holders have a demerit point threshold of four demerit points. The accumulation of four or more demerit points during this period will result in suspension of the licence for three months. Any suspension periods served do not count towards the required provisional tenure period required to upgrade to a full driver licence.

Provisional licence holders must have a blood or breath alcohol concentration of zero.

It is an offence to drive a motor vehicle that displays 'P' plates when the driver of the vehicle is not a provisional driver.

Members of the Australian Defence Force who are holders of an interstate learner licence may obtain their provisional licence through the one-off assessment with a Government Assessor, or through the logbook system. An applicant who chooses the logbook system must have a current interstate learner licence and that licence must remain current through the full logbook training period up to and including the issue of an ACT provisional licence.



After the provisional period of three years has been completed, you can obtain a full licence which is renewable on each birthday divisible by five years. To obtain a full licence at this time you can attend an Access Canberra Service Centre with Proof of Identity or renew your licence online.

Probationary



All drivers and riders returning to driving after a court imposed licence disqualification will need to complete an approved alcohol and drug awareness course before being eligible to be issued with a probationary licence.

Probationary licence holders must drive or ride with a blood or breath alcohol concentration of zero.

Restricted



Some drivers and riders who have received a court imposed licence disqualification and have completed an approved alcohol and drug awareness course, may apply to the court for a restricted licence permitting them to drive during specific hours or for specific purposes, but these are only issued in very limited circumstances.

People whose licences have been suspended under the demerit point scheme are not eligible to apply for a restricted licence. Restricted licence holders must drive or ride with a blood or breath alcohol concentration of zero.







Heavy rigid (HR)

Conditions that may be imposed on a driver licence

A - automatic transmission

Conditions that may be imposed on your driver licence are:

a motor vehicle that has a gross vehicle mass (GVM) more than 8 tonnes and has 3 or more axles (whether or not the wheels on those axles are on the road)

a bus consisting of more than one rigid section which are connected to one another so as to allow rotary movement and passenger access between the sections







You can drive:

any vehicle or combination of vehicles the holder of a medium rigid vehicle licence is authorised to drive a heavy rigid vehicle (this includes a prime mover not towing a trailer)

a heavy rigid vehicle that is towing a single trailer (other than a semi trailer) that has a GVM not more than 9 tonnes

Heavy combination (HC)

a prime mover to which is attached a single semi-trailer that has a gross vehicle mass (GVM) more than 9 tonnes plus any unladen converter dolly, or

a rigid motor vehicle to which is attached a trailer that has a GVM more than 9 tonnes plus any unladen converter dolly.

Heavy combination vehicle - HC

This vehicle is either:

Other (X) conditions

If you've been issued with an X condition, you are subject to any of the following conditions or limitations.

XA - Periodic medical review required

Your licence is subject to a periodic medical review.

XB - Annual criminal history check

Your licence is subject to an annual criminal history check.

XC - For training and assessment only

Your licence is for training and assessment purposes only.

This is usually issued if you need a driving test or rehabilitation assessment before your licence renewal or re-licensing after a medical suspension.

XD - No driving between sunset and sunrise

You must not drive between sunset and sunrise.

XF - Licence class area restricted

Your licence is only valid in a specific area.

XG - Drive in company of rehabilitation service

You can only drive when accompanied by an instructor experienced in rehabilitation training.

This is applied if you are suffering from a medical condition and require training prior to re-applying for your driver licence.

XH - In company of full licence holder

You may only drive when accompanied by a person holding a full licence for the class of vehicle being driven.

XI - Not to exceed 80 km/h in car

A moped—fitted with an electric motor or an internal combustion engine (with a maximum capacity of 50mL) with a maximum manufacturer's top rated speed of 50km/h that is not a bicycle. Any other vehicle with a larger engine or faster top rated speed is classed as a motorcycle

A learner approved motorcycle (2 or 3 wheel), with or without a trailer

Note: A learner approved motorcycle is a production motorcycle that is fitted with an electric motor, or has an internal combustion engine with a maximum engine capacity of 660mL and:

has maximum power to weight ratio of 150kW per tonne (t)

has not been modified other than for an allowable modification

is included on our learner approved motorcycle list.

An allowable modification, for a learner approved motorcycle is a modification:

designed to enable a person with a physical impairment to ride the motorcycle

or

to the seating capacity of the motorcycle.

Either of these modifications must be approved under the Vehicle Standards and Safety Regulation.

Modifications that increase the maximum engine power of the motorcycle are not considered allowable.

Examples:





Class code R - Full sized motorcycle

A motorcycle (2 or 3 wheel) with unlimited engine size, with or without a trailer.

Specially constructed vehicle class

The specially constructed vehicle licence class, class UD, may be listed separately on your licence. However, the class UD is no longer issued to new applicants—specially constructed vehicles may be driven under the authority of a class C provisional, probationary or open licence. Mobile cranes over 4.5t GVM cannot be driven on a class C licence—you will need the appropriate class of heavy vehicle licence to drive a mobile crane.

Examples:



- **A** You may only drive a motor vehicle with an automatic transmission.
- **B** You may only drive a motor vehicle with a synchromesh gearbox.
- I If you are convicted of a high-risk drink driving offence you will be subject to an alcohol ignition interlock program on completion of your disqualification period. - **\$** You may only drive while wearing corrective lenses.
- **V** You may only drive a motor vehicle that has been adapted or fitted with driver aids in order to obey a written notice given to you by the Department

Class code UD

Vehicles that you can drive under this class:

Specially constructed vehicle Front end loader

A specially constructed vehicle with or without trailer.

A specially constructed vehicle is:

an agricultural machine (such as a tractor or harvester) which is a self-powered machine built to perform agricultural tasks and used for agricultural purposes (such as harvesting)

a crane, other than a mobile crane of more than 4.5t GVM, or a hoist or load shifting equipment (see note) earthmoving equipment

any other motor vehicle that is not constructed to carry passengers or a load, except things used in performing the vehicle's function. This class does not include a motor vehicle with a chassis that is substantially the same as a truck chassis, or a motorcycle. Note: A person must not carry out high risk work unless they hold a licence for that class of work. A high risk work licence may be needed to operate mobile machinery such as cranes, hoists or forklifts. Find out more about high risk work licences.

has a maximum weight of 4.5 tonne (t) gross vehicle mass (GVM)

is built or fitted to carry no more than 12 adults, including the driver.

A moped—fitted with an electric motor or an internal combustion engine (with a maximum capacity of 50mL) with a maximum manufacturer's top rated speed of 50km/h that is not a bicycle. If you are riding a moped on a car licence you must not carry a passenger

A specially constructed vehicle with or without a trailer.

Note: A specially constructed vehicle may not be driven on a class C learner licence.

You can drive:

A class HR vehicle

A truck (including a prime mover or mobile crane) over 8t GVM with a trailer of more than 9t GVM.

Motor vehicles authorised to be driven

A motor vehicle authorised to be driven by a licence of a preceding class.

A motor vehicle (other than a special purpose vehicle) with 2 axles and a GVM greater than 8 tonne.

A motor vehicle included above towing a single trailer (other than a semi-trailer) with a GVM not greater than 9 tonne, subject to the combination mass limits fixed under the Heavy Vehicle National Law (South Australia).

A special purpose vehicle with 2 axles and a GVM greater than 8 tonne, or 3 or more axles and a GVM not greater than 15 tonne.

May tow:

any farm implement

any trailer with a GVM not exceeding 9 tonne provided it is within the GCM of the towing vehicle.

Driver's licence must be carried if driving a vehicle over 4.5 tonne GVM.

Minimum driving experience

Must have held a class C for at least one year.

HR class

Motor vehicles authorised to be driven:

A motor vehicle authorised to be driven by a licence of a preceding class.

A motor vehicle (other than an articulated motor vehicle or a special purpose vehicle) with three or more axles and a GVM greater than 8 tonne.

A motor vehicle included above towing a single trailer (other than a semi-trailer) with a GVM not greater than 9 tonne, subject to the combination mass limits fixed under the Heavy Vehicle National Law (South Australia).

An articulated bus with three or more axles and a GVM greater than 8 tonne.

A special purpose vehicle with three or more axles and a GVM greater than 15 tonne. May tow:

any farm implement

any trailer with a GVM not exceeding 9 tonne provided it is within the GCM of the towing vehicle.

Driver's licence must be carried if driving a vehicle over 4.5 tonne GVM.

Minimum driving experience

Must have held a class C for at least two years or a class LR or MR for at least one year.

HC class

Motor vehicles authorised to be driven:

A motor vehicle authorised to be driven by a licence of a preceding class.

A prime mover to which is attached a single semi-trailer (whether or not any unladen converter dolly or low loader dolly is also attached).

A rigid motor vehicle to which is attached a single trailer with a GVM greater than 9 tonne (whether or not any unladen converter dolly or low loader dolly is also attached).

Driver's licence must be carried if driving a vehicle over 4.5 tonne GVM.

Minimum driving experience

not drive a motor vehicle with any concentration of alcohol or illegal substances in their blood

not drive a high-powered vehicle while under the age of 25 unless a certificate of exemption from high-powered restrictions has been issued.

P1 licence holders under the age of 25 years must not drive:

between midnight and 5:00 am

with more than one passenger aged 16 to 20 years (excluding immediate family members) unless a Qualified Supervising Driver is seated next to you or you meet the exemption criteria.

P2 licence holders

The holder of a P2 licence is subject to the same conditions as a provisional 1 licence holder, except for the following:

no longer required to display 'P' plates

able to use mobile phone fuctions such as hands-free and Bluetooth technology.

P2 licence holders under the age of 25 years are able to drive:

between midnight and 5:00 am

with more than one passenger aged 16 to 20 years.

For further information visit the P2 provisional licence page on the MyLicence website.

If the holder of a provisional licence breaches any of these conditions, they will be issued with a disqualification notice.

Probationary conditions

Probationary conditions may be applied to a driver's licence following a licence disqualification.

Probationary conditions generally apply for 12 months, but may be longer in some instances.

If a licence is subject to probationary conditions, the term 'probationary conditions' will be printed on the front of the licence photo card.

The holder of a licence subject to probationary conditions:

must not drive a motor vehicle or attempt to put a motor vehicle in motion on a road with any concentration of alcohol or illegal substances in their blood or saliva

must carry their licence at all times whilst driving

must not incur two or more demerit points during the probationary licence period

are not able to supervise the driving of a person with a learner's permit.

Alcohol interlock conditions

A person applying for a licence following a disqualification ordered by a court due to a serious drink driving offence will be issued a licence subject to mandatory alcohol interlock conditions.

Licence holders subject to alcohol interlock conditions must:

Must have held a class MR or HR for at least one year.

MC class

Motor vehicles authorised to be driven

Any motor vehicle or combination of motor vehicles except a motor bike or motor trike (Includes B doubles and road trains).

Driver's licence must be carried if driving a vehicle over 4.5 tonne GVM.

Minimum driving experience

Must have held a class HR or HC for at least one year.

R-DATE

Motor vehicles authorised to be driven:

A motor bike or motor trike that:

has an engine capacity not exceeding 660 mL and a power to weight ratio not exceeding 150 kW per tonne

is of a kind approved by the Registrar by notice in the Government Gazette.

(An * (asterisk) means the expiry date of the learner's permit or the date falling one year after class R-Date was endorsed on the licence. It indicates the date on which the holder may apply for a class R licence.)

Minimum driving experience

Must be at least 19 years of age.

Must have held a motorcycle learner's permit for at least 12 months.

R

Motor vehicles authorised to be driven:

Any motor bike or motor trike.

Minimum driving experience

Must have held a class R-DATE for at least 2 years.

Motorcycle - R

Any 2 or 3 wheeled motor vehicle. Must satisfactorily complete all required training and assessments prior to receiving.

Minimum age: 17
